#### INSTRUCTIONS FOR USE

The color masterbatch is supplied as a single component material. Stirring the material prior to use is recommended to ensure homogeneity. Combine the masterbatch with liquid silicone rubber or low consistency materials through manual mixing or by using a third line on an injection molding machine. Suggested concentration is 2 pph masterbatch by weight. The biological testing performed in support of these products does not cover masterbatch concentration in excess of 4 pph. Combine and cross-blend components until thoroughly mixed. Take the usual precautions to avoid contamination of the materials.
